PARTNER AGENCIES

OVER HALF OF THE RECIPIENT PARTNER AGENCIES ARE FAITH-BASED ORGANIZATIONS REPRESENTING ALL MAJOR FAITH TRADITIONS. MANY OF THESE ORGANIZATIONS OPERATE FOOD PANTRIES WHICH SERVE THE WORKING POOR. APPROXIMATELY HALF OF THE AGENCIES HAVE "ON SITE" FEEDING PROGRAMS INCLUDING SHELTERS FOR THE HOMELESS, DAY CARE CENTERS, SENIOR CITIZEN CENTERS, AND ADDICTION TREATMENT FACILITIES FOR LOW INCOME. ON A MONTHLY BASIS 70,228 PEOPLE WERE SERVED THROUGH THESE ON-SITE PROGRAMS AND APPROXIMATELY 25,797 HOUSEHOLDS RECEIVE FOOD ASSISTANCE IN ANY GIVEN MONTH.
